## Govinda remains under close medical supervision after collapsing at home

Mumbai, Nov 12 (IANS) Bollywood actor Govinda was rushed to CritiCare Hospital in Juhu, Mumbai, on Wednesday after he reportedly lost consciousness at his residence in the early hours.

The 61-year-old star is currently under close medical supervision, with doctors keeping a watchful eye on his condition. Govinda's friend and legal advisor, Lalit Bindal, confirmed the news to IANS. He stated that the actor initially received medication following a telephonic consultation with a doctor but was later rushed to the hospital around 1 a.m. for emergency treatment.

Lalit also informed us that the veteran actor was rushed to the hospital after he became unconscious at his residence. Govinda is currently under



observation.

Govinda is hospitalized just a day after visiting veteran actor Dharmendra, who is currently recovering at Breach Candy Hospital. In a video shared online, the 'Raja Babu' actor was seen leaving the hospital with a somber expression.

This marks the second time Govinda has been admitted to a hospital within a year. In October last year, he was admitted to the same hospital after accidentally injuring his leg with a licensed revolver.

The 'Hero No 1' actor suffered a wound below his knee and underwent an hour-long surgery in the ICU to safely remove the bullet.

Reportedly, Govinda was getting ready to travel to Kolkata and was putting his revolver back in the cupboard when it accidentally went off. The actor was discharged from the hospital three days later. Upon leaving, Govinda greeted fans and members of the media with folded hands.

Speaking to the media, the actor had said, "I was about to leave for a show in Kolkata. It was about 5 in the morning. Aur uss time par vo giri aur chal padi (and it just fell and went off). I was shocked by what happened and when I looked down, I saw a fountain of blood.

## Hester Biosciences consolidated Net Profit in Q2FY26 rise 71% to Rs. 14.33 crore

Ahmedabad: Hester Biosciences Limited, one of India's leading animal health company, manufacturing vaccines and health products has reported consolidated net profit of Rs. 14.33 crore for the Q2 FY25-26, rise of 71% as compared to the net profit of Rs. 8.39 crore reported in the second quarter of FY 2024-25. Revenue from operations of the company for the Q2FY26 was reported at Rs.70.97 crore. EBITDA for Q2FY26 was reported at Rs. 23.60 crore (EBITDA margin 33%) as against EBITDA of Rs. 21.96 crore (EBITDA margin 26%) in Q2FY25. EPS for Q2 FY26 was Rs. 16.85 per share. Consolidated results include operations of subsidiaries from Nepal and Tanzania.

Net Profit for H1 FY26 was reported at Rs. 31.63 crore, up 99% Y-o-Y from Rs. 15.88 crore in the corresponding period last year. EBITDA for H1FY26 was reported at Rs. 49.78 crore (EBITDA margin 32%) as against EBITDA of Rs. 41.69 crore (EBITDA margin 25%) in Q2FY25. For H1 FY26, company reported revenue of Rs. 155.07 crore. The company maintained strong operational discipline, through controlled overheads, process standardisation, and efficient manpower deployment. The focus remains on margin protection and cost optimisation, while positioning for an expected recovery in volumes during the second half of the year. HesterAfrica reported a net profit of INR 4.82 crore

in Q2 FY26 and INR 10.32 crore in H1 FY26, on top lines of INR 5.99 crore and INR 23.22 crore, respectively. ### Sensex, Nifty open in green over US-India trade talks, Bihar exit polls

Mumbai, Nov 12 (IANS) The Indian benchmark indices opened in green zone on Wednesday, amid reports of an imminent India-US trade deal and exit polls in Bihar predicting decisive majority for NDA. As of 9.25 am, Sensex advanced 496 points, or 0.59 per cent at 84,367 and Nifty inched up 147 points, or 0.58 per cent to 25,842. The broadcap indices performed in line with the benchmarks, with the Nifty Midcap 100 up 0.55 per cent and the Nifty Smallcap 100 adding 0.61 per cent. Max Healthcare and Tech Mahindra were among the major gainers in the Nifty Pack, while losers included Maruti Suzuki and Trent. All sectoral indices were trading in green except Nifty FMCG, mixed with most of them trading with mild negative bias. Nifty IT and Nifty Oil and Gas were the standout gainers - up 1.26 per cent and 0.95 per cent. "With reports of an imminent India-US trade deal and exit polls showing the NDA winning Bihar, sentiments have improved. This will strengthen bulls but not enough to give markets a decisive breakout and sustained rally," said market watchers. Based on current trends, FIIs may sell again at higher levels till the AI trade continues, they added.

### Tata Motors' commercial vehicle arm debuts at 28 pc premium, shares fall over 3 pc post listing

Mumbai, Nov 12 (IANS) The shares of Tata Motors' commercial vehicle business made a strong debut on the stock exchanges on Wednesday, listing at Rs 335 per share on NSE, up 28 per cent over the discovered price of Rs 260.75. On the BSE, the shares were listed at Rs 330.25, a premium of 26 per cent from their earlier valuation of Rs 261.90 per share. However, post-listing the shares -- which will now officially be known as Tata Motors Ltd -- fell by around 3.5 per cent from the listing price to a low of Rs 322.60 on the NSE. At around 11:35 am, the stock was trading at Rs 328.65, down 1.90 per cent from the listing price on NSE. Meanwhile, shares of Tata Motors Passenger Vehicle were trading at Rs 404.75, down 0.69 per cent. The listing marks the completion of the demerger of Tata Motors' commercial vehicle and passenger vehicle businesses, a strategic move aimed at enhancing business focus and unlocking value for shareholders.

## Indian rupee expected to trade in 88.5-89 per dollar range till Nov end: Report

Mumbai, Nov 12 (IANS) The movement in the dollar and progress in the US-India trade negotiations will determine the Indian rupee's direction in November, a report said on Wednesday, adding that rupee will trade in the range of 88.5-89 per dollar till month end. The outlook, however, hinges on the US dollar's

trajectory and US macro data on inflation and the labour market, which will influence the Federal Reserve's rate decision in December, the report from Bank of Baroda (BoB) said. Any positive development on the US-India trade deal is likely to lift investor sentiments, the bank said, adding that

concerns about higher US tariffs' impact on the domestic economy are weighing on foreign portfolio investor (FPI) flows. Rupee remained steady in the last month, even though it continued to trade near a record low amid a stronger dollar, sluggish inflows and strong demand from importers.

## India's DC stock surpasses 1.5 GW; 260 MW added during 9M 2025: Report

New Delhi, Nov 12 (IANS) India's data centre (DC) capacity crossed 1.5 gigawatt (GW) for the first time during the first nine months this year (9M 2025), a report said on Wednesday. A supply of 260 MW has been added between January and September this year. "The growth is mainly driven by rapid digitalisation, favourable government regulations, and increasing corporate investments in Artificial Intelligence (AI)," CBRE South Asia, a real estate consulting firm, stated in its report. According to the report, Mumbai leads the country's total DC capacity with a 53 per cent share of the total, around 1,530 MW at the end of September this year. This is mainly due to its proximity to global internet exchange points and a key entry location for worldwide submarine cables.
